## FIRST CALL – NOTES FROM THE FRONT

### VETERANS ~ A TARGET OF OPPORTUNITY

In the lead up to the 2004 Presidential election Howard Dean began his stump speeches with a very powerful and effective opening. He would start his speech by saying repeatedly—“What I want to know is ...”, going on to list the issues on which both parties were failing. I hope that Governor Dean will forgive me for using his construct in this editorial.

Of course our asking, “What I want to know is ...”, has nothing to do with political parties; it has much to do with the Congress, the Courts, the Administration, the Executive Branch in general, and the Departments of Defense and Veterans Affairs in particular. Here are some of the things that “I want to know”.

What I want to know is why the Administration, and all administrations going back to Truman's, feel that when it is necessary to make a foreign policy point we must lead with our military? If this is our policy, why do we bother paying for a State Department?

Truman sent us into Korea and Eisenhower pulled us out—not a direct defeat, but no victory, merely a return to status quo with 36,516 US and estimated 3,000,000 Koreans from both sides dead plus at least 400,00 Chinese.

Johnson sent several million into an unnecessary war in an unknown area of the world, resulting in 58,212 US deaths, 6,000+ allied deaths 1,100,00 Vietnamese military and 2,000,000+ Vietnamese civilians (both sides)—and a defeat.

Reagan seemed to send troops into any tiny trouble area of his choosing whenever he needed a poll boost—no defeats, but no real victories.

Bush I sent Marines into Beirut for some obscure foreign policy reason and then Clinton withdrew them after one bombing, logging another defeat.

Bush I sent troops into Panama to capture and depose our client Manuel Noriega—more dead and another self-claimed “victory”.

Bush I sent troops into Somalia and then Clinton pulled them out after the Mogadishu incident to chalk up yet another defeat—and more dead.

Bush II decided that as long as we had a military we might as well use them to strengthen the office of the President (and to make him look like a warrior) so he started two wars with marginal reasons for the first and lies for the second.

Bush II and Obama have presided over these two open wars (and who knows how many clandestine wars) by using and re-using the military to exhaustion. The results, 10 years on, have been stalemate and, if not a complete defeat, no victory by any recognizable criteria. Of course it has also meant 7,521 US and allied dead, and an estimated 900,000+ Iraqi and Afghani military and civilians dead. In the US alone, as a result of this folly, we have 103,000 wounded and injured, and at least 300,000 more “walking wounded” with PTSD and TBI, perhaps more.

**What I want to know is** why, when we need to save money, active military and veterans are the immediate and most convenient target?

Please don't misunderstand. The administration and Congress do not attack any of that unnecessary military spending, those failed and failing defense projects, or any defense program that will adversely affect some voting bloc or Congressional district. They attack serving military, their dependents, and veterans with impunity, however.

Eisenhower sent married troops to overseas assignments and then denied their dependents travel to join them—saved a ton of money. He even added a year to the tours of many who were over there already.

Nixon promised recomputation of benefits to retirees in return for their vote and then reneged on the promise—twice—too expensive.

Carter froze pay raises for the military in a time of hyperinflation. He even outlawed the wearing of the uniform in the DC area and charged serving military to park their cars on military installations.

Reagan resumed pay raises but discounted retirement raises.

Bush I began reducing the military force and now we have serious under manning vis-à-vis the mission.

Clinton continued the reduction of the force and began the contributions for medical care with the conversion of CHAMPUS into the various levels of TRICARE with its deductibles and “cost-sharing”.

Bush II saved money initially by treating Reservists and Guardsmen and their dependents as second-class recipients of pay, benefits, medical treatment, and rehabilitation.

Obama proposes to raise fees for medical treatment and pharmaceuticals to all military and retirees.

**What I want to know is** why Congress doesn't stand up for the military and veterans on all of these issues except in their annual Veterans Day and Memorial Day speeches?

Yes, Congress has enacted various forms of the GI Bill, but when times got tough those benefits have been cut back over and over again. Right now they are not bad, but the execution of the program suffers—just ask a veteran student today.

Yes Congress enacted TRICARE for Life which benefits all retirees (full disclosure—I am one of those). But each time the budget brouhaha starts the question is raised whether or not this is “too much”, and can we still “afford it”.

**What I want to know is** why, when members of Congress claim that austerity is required and that trillions of dollars must be saved, is one of the first targets military retirement?

**What I want to know is** why Congress always asks if we can afford benefits for soldiers and retirees, yet never seems to ask if we can afford pointless wars?

**What I want to know is** why Congress insists that the pharmaceutical companies not be required to negotiate their outrageous drug prices with the American people, yet they freely and quickly jump on the bandwagon to charge veterans more for their drugs? They take a few million from veterans' pockets and hand that money plus billions more to the drug companies, who sequester the profits offshore and don't pay taxes on it.

**What I want to know is** why Congress apparently has made the Secretary of Veterans Affairs the only dictator in the Executive Branch, to wit:

**38 USC 511 ~ DECISIONS MADE BY THE SECRETARY**

(a) The Secretary shall decide all questions of law and fact necessary to a decision by the Secretary under a law that affects the provision of benefits by the Secretary to veterans or the dependents or survivors of veterans. ... the decision of the Secretary as to any such question shall be final and conclusive and may not be reviewed by any other official or by any court, whether by an action in the nature of mandamus or otherwise.

**What I want to know is** why are Representatives and Senator's promises to lobbyists more important to them and more binding on their actions than their promises to all of us, their constituents. They have even told us that their promises to lobbyists are more important and binding than their oath to protect and defend the Constitution!

**What I want to know is** why the Executive Branch does not demand excellent performance from its various departments, particularly the Department of Defense and the Department of Veterans Affairs, and why is no one ever fired for incompetence?

**What I want to know is** why DoD and the VA are allowed, year after year, to pursue (and most often overrun) programs of questionable value, and to pay for them by cutting services to the people for whom their benefit programs are designed?

**What I want to know is** why the VA is allowed to continually restrict the locations where services are provided to veterans, and to constrain the services

provided at the remaining locations, yet they are never required to ameliorate the effect of their management decisions on the individual veteran?

**What I want to know is** why it can take an operation like the West LA Veterans Center 13 years to develop a “Master Plan”, when they are never required to meet the goals of any plan, “Master” or otherwise, current or previous? During this entire time that same operation freely gave away rights of use of various parts of the facility to commercial and civilian community enterprises and activities, while allowing the remaining physical plant that is supposed to serve veterans to deteriorate. They even let the dogs of their wealthy civilian neighbors use the grounds, but deny entry to veterans.

**What I want to know is** why is the Veterans Benefits Administration allowed to continually perform so abominably in the claims process— performance at a level that would cause most of their managers and personnel to be fired in industry—and there is no reaction from the White House, the VA itself or Congress?

**What I want to know is** why the VA believes— and has presented to the courts— that veterans have no constitutional right to their benefits?

**What I want to know is** why certain sitting federal judges agree that veterans do not have a constitutional right to their benefits, yet they believe in the constitutional right of corporations to have benefits and rights that logic and our basic high school civics course taught us only apply to living human beings?

**What I want to know is** why the Courts, in many states and municipalities oppose the establishment of veterans’ courts, even when they have been shown in places like Buffalo, New York to benefit not only the

veteran, but also the community at large? (The Governor of my own state, apparently at the prodding of the judicial establishment, just vetoed a law, passed without opposition in the legislature, authorizing the establishment of such courts throughout the state).

All of these questions and many more are legitimate questions not only by veterans, but also by all citizens in a republic.

So finally—

**What I want to know is** why should I even have to ask these questions?

**What I want to know is** will anyone ever answer the questions?

**President Obama?**

**Speaker Boehner?**

**Chief Justice Roberts?**

**Secretary Pinetta?**

**Leader Reid?**

**Secretary Shinseki?**

**Someone?**

**Anyone?**

### **VCS - VUFT LAWSUIT UPDATE:**

#### **STATUS OF OUR CLASS ACTION LAWSUIT**

*The following is the current status of our lawsuit as provided by Ryan Hassanein of Morrison & Foerster.*

[The VA has petitioned for a re-hearing before the 9<sup>th</sup> Circuit)

On August 9, Veterans for Common Sense and Veterans United for Truth filed their response to VA's petition for rehearing.

As explained in the response, VA's petition raised four legal arguments as to why the case should be reheard, but VA did not even raise three of those arguments in the original appeal to the Ninth Circuit Court of Appeals. This is particularly interesting because in raising the arguments, VA's petition described these issues as "questions of exceptional importance." Yet, they were not so important that VA felt it necessary to raise these issues in the original appeal.

The three new issues are:

- 1) VA now claims that veteran applicants do not have a constitutionally protected property interest in mental health care or disability compensation.
- 2) VA now claims that it enjoys sovereign immunity, and therefore courts cannot review its unconstitutional actions.
- 3) VA now claims that VCS and VUFT do not have standing to pursue their constitutional claims.

In addition to these new issues, VA also claims that the Veterans Judicial Review Act strips the court of any jurisdiction to hear these constitutional claims.

VA's position - if correct - would have far-reaching implications for veterans. It would mean that veterans have fewer constitutional rights than any other applicants for benefits. And it would mean that veterans have no recourse in Article III federal courts to challenge unconstitutional actions of VA.

In response, VCS and VUFT noted:

- 1) That the federal courts - under the Administrative Procedure Act and otherwise - are open to provide remedies for constitutional violations by federal agencies and federal officials;
- 2) That the Veterans Judicial Review Act does not prevent the district court from hearing these constitutional challenges;
- 3) That VCS and VUFT have standing to bring these claims on behalf of themselves (as organizations) AND on behalf of their members; and
- 4) That veterans have a constitutionally protected property interest in timely medical care and timely resolution of their appeals from service-connected death and disability compensation decisions, and that the Ninth Circuit panel was correct in holding that the egregious delays violated veterans' constitutional right to due process.

We believe that the Ninth Circuit panel correctly resolved all of these issues, and that rehearing is not necessary.

#### **MORE EXCUSES AND DELAYS FROM THE V.A.**

New York Times Editorial Board – 21 August 2011

It has been more than three months since a panel of the United States Court of Appeals for the Ninth Circuit accused the Department of Veterans Affairs of "unchecked incompetence" and unconscionable delays in caring for veterans with mental health problems. Instead of working with the plaintiffs to address the court's concerns, the V.A. is appealing the ruling.

The 2-to-1 decision in a lawsuit brought by two nonprofit groups, Veterans United for Truth and Veterans for Common Sense, found that the V.A. bureaucracy was so extremely slow and unresponsive that veterans were being denied their constitutional right to mental health care and to the timely adjudication of disability claims. It cited as evidence the high veteran suicide rate — an estimated 18 a day among the nation's 25 million veterans, and four to five a day among those being served by the V.A.

#### **TOM COBURN'S CUTS: MILITARY'S TRICARE PRIME HEALTH CARE PROGRAM TARGETED**

Sen. Tom Coburn (R-Okla.) wants to cut taxpayer funding for non-military elements of the Defense Department, starting with making retired, uninjured service members pay more for what he described as "extremely low-cost health care for life" for themselves, their spouses and dependents under the Tricare Prime system.

For military retirees eligible for Medicare, he also wants to raise the co-payments that they are charged to be in Tricare for life, the second payer for health care after Medicare. In addition, he wants to increase low fees that Tricare beneficiaries pay for pharmaceuticals purchased at their local drugstores.

### **HOUSE COMMITTEE PASSES JOBS BILL FOR VETERANS**

A key House committee approved a \$1.5 billion veterans' employment bill Thursday that promises a new job retraining program for veterans aged 35 and older who have been out of work for at least 26 weeks as well as improvements in transition assistance, job placement and professional licensing initiatives for all veterans. The House Veterans' Affairs Committee passed the Veterans Opportunity to Work Act, HR 2433, on a 17-5 vote, with opposition coming from some Democrats opposed to how the employment programs would be funded. The bill would reduce pensions for some low-income veterans in nursing homes and delays previously planned reductions in fees on veterans' home loans.

Rep. Bob Filner of California, the committee's ranking Democrat, said using home loan fees to pay for employment aid is "strange, hypocritical and even tragic." He also said the programs in the bill would not provide any immediate jobs. "Retraining is great, but if there are no jobs what good does it do?"

### **SUBCOMMITTEE GRILLS VA ON VETERAN-OWNED SMALL BUSINESSES**

The Veterans Affairs Department was in the hot seat Thursday after an audit found it had awarded at least 1,400 contracts intended for veteran-owned companies to ineligible businesses. The contracts were specifically set aside for veteran-owned small businesses and service-disabled veteran-owned small businesses, but because companies can self-identify, many falsely identified themselves as veteran-owned.

"Seventy-six percent of the businesses we reviewed were ineligible for either the program and/or the specific [veteran-owned small businesses] or [service-disabled veteran-owned small businesses] contract award, potentially resulting in \$2.5 billion awarded to ineligible businesses over the next five years," said Belinda Finn, assistant inspector general for audits and evaluations at VA, testifying before the House Veterans' Affairs Committee's oversight panel.

### **EFFORTS TO PROTECT MILITARY PAY STALLED**

With the threat of another government shutdown looming, the topic of military pay is once again making the news. Thankfully, the last two times the issue came up, a shutdown was avoided and military servicemember's pay was unaffected. However, the real issue is the threat continues to cause undue stress on military servicemembers and their families.

Earlier this year Rep. Louie Gohmert (R-Texas) introduced the "Ensuring Pay for Our Military Act of 2011" to make sure that pay for military members is never used as a bargaining chip. His bill currently has 203 co-sponsors representing members from both parties. However, his bill has been languishing in the Armed Services Committee and Transportation and Infrastructure Committee. "The military ought to be off the table. They should not be one of the poker chips to try to vote for a bill they otherwise wouldn't vote for," Gohmert said.

RALEIGH, N.C. -- He killed her, Joshua Stepp admitted. He slammed the face of his 10-month-old stepdaughter into a carpeted floor, roughed her up as he changed her diaper, stuffed wet toilet paper down her throat, and soon she was dead. But Stepp, a 28-year-old former Army infantryman who saw combat in Iraq, insists that he is not guilty of first-degree murder. His post-traumatic stress disorder left him incapable of premeditating the killing of tiny Cheyenne Yarley in November 2009, he and his lawyers say.

... After a decade of combat overseas, growing numbers of veterans are relying on PTSD as a central element of their defenses in criminal cases. Stepp's trial is being closely watched as one measure of just how far defense lawyers are able to push in arguing that the disorder influences veterans' criminal behavior.

Staff Sgt. Nicholas Lanier has entered what he calls the "vast unknown." A combat veteran and father to four daughters, he can't remain in the military because of a serious back injury earned in Iraq. But he can't yet accept a civilian job because he doesn't know when the military will discharge him. He has no clue how much the government will pay him in disability compensation related to his injury, so he can't make a future budget. He just waits.

"I don't have any idea what the end state is going to be on the other side. When you have a family and you are trying to plan for the future, that's going to affect a lot of things," said Lanier, a 37-year-old soldier stationed at Fort Stewart, Ga., who walks with a limp because of related nerve damage. "The only known is that it takes time."

Thousands of troops are like Lanier: not fully fit to serve but in limbo for about two years waiting to get discharged under a new system that was supposed to be more efficient than its predecessor. And the delays are not only affecting service members, but the military's readiness as well. New troops can't enlist until others are discharged.

The graying veteran in a wheelchair was found in the parking lot of a Westside cold weather shelter wearing hospital pants, carrying a urine bottle and screaming for help. Senior officials at the Los Angeles city attorney's office say they believe James Boykin was "dumped" Dec. 1 at the shelter after his toe was removed at the nearby Department of Veterans Affairs medical center because of a bone infection. Moreover, according to city prosecutors, VA officials blocked an investigation that could have shed light on whether there were other similar incidents.

"This was an unprecedented interference with an investigation," said Jeffrey B. Isaacs, who heads the office's criminal and special litigation branch. VA officials strongly dispute the allegations involving Boykin, adding that the city does not have authority to conduct a criminal investigation on federal property. Three internal inquiries and an investigation by the VA's Office of Inspector General found no evidence that Boykin was sent to the shelter against his will or without the means and ability to care for himself.

TUCKERTON, N.J. – A wheelchair-bound Vietnam veteran with muscular dystrophy, from New Jersey, was enjoying his \$15 million whistleblower reward Wednesday, after he uncovered a multimillion dollar medical aid fraud.

Richard West, 63, of Tuckerton, first found his Medicaid benefits were wrongly maxed out in 2004 during a visit to the dentist and spent the past seven years investigating the scam, the New York Post reported.

Following the dentist visit, West returned home and examined his own records, when he found Maxim Healthcare -- the agency that provides his health aides -- had billed the government for care he never got, including visits from nurses he never met.

After spending months trying to get government officials to investigate the scam, he hired a lawyer and filed a federal lawsuit. His efforts resulted in the largest financial settlement in home healthcare fraud history.

### **HOMELESS VETERAN NUMBERS DROP BY 55,000: VA**

WASHINGTON (Reuters) - The number of homeless veterans on any given night has dropped by over 55,000, the Department of Veterans Affairs said on Friday, due in part to programs like the \$46.2 million announced Thursday to provide permanent housing for 6,790 homeless veterans.

Despite a still-stagnant economy and increased troop drawdowns leading to potentially higher numbers of homeless veterans, VA Deputy Press Secretary Drew Brookie said the number of veterans that are homeless each night has dropped from an estimated 131,000 in 2009 to 75,700 as of June this year.

Their only alternative, Marrero said, was to stay in parks in nearly 100-degree heat. At night, Marrero and her children slept at the Salvation Army shelter on Alexander Street.

### **VETERANS COURTS EASE THE WAY**

His third drunken driving charge be damned, Vietnam veteran Bob Andries stood before a judge and demanded respect. Andries had spent two years in Vietnam as a machine gunner aboard a helicopter. The recipient of a Purple Heart, he returned stateside in 1970 as an angry, broken man who drank heavily to numb the symptoms of post-traumatic stress and other mental health problems.

Forty years later, he appeared in District Court in Ionia, Mich., and seethed after learning that a drunken driving conviction from 1972 was being held against him. "He was a time bomb," said the judge, Raymond Voet, who hasn't forgotten the glare Andries gave him that day. "We didn't know what he was going to do."

Voet threw Andries in jail, realizing in that instant what the court needed to do to help him. Voet and other judicial officials had been scheduled to meet later that day to discuss forming a court tailored to rehabilitating veterans with mental illnesses or drug and alcohol problems directly related to their time in service. Voet and the others decided Andries could not wait. On that day - Oct. 9, 2009 - the first veterans court in Michigan, and one of the first in the nation, was born.

Today, at least 77 veterans courts operate in 28 states. The first one started in Buffalo, N.Y., in 2008. Although there is no way to gauge the success of veterans courts - analysts say it is too early to tell - judges who run them universally say they are making a big difference in veterans' lives. Successful completion of a veterans court typically means charges are reduced or dropped.

"It's the least we can do for them, to get them back in the community and be productive in the community." said David L. Jordon, a District Court judge who leads a veterans court in East Lansing, Mich.

## **VETS WITH PTSD, GOVERNMENT REACH SETTLEMENT**

WASHINGTON - More than a thousand Iraq and Afghanistan veterans with post-traumatic stress disorder would be given lifetime disability retirement benefits such as military health insurance under the terms of a settlement reached between the government and the veterans.

... The settlement stems from a 2008 class action lawsuit filed in the U.S. Court of Federal Claims in Washington by veterans unable to serve, at least in part, because of the anxiety disorder who said they were illegally denied benefits.

The law requires the military to give a disability rating of at least 50 percent to troops discharged for PTSD, but each of the plaintiffs received a disability less than that, said Bart Stichman, co-executive director of the National Veterans Legal Services Program, a nonprofit organization that represented the veterans.

As part of the lawsuit, the military in January 2010 said it would expeditiously review the cases. But attorneys for the veterans grew concerned about the pace in which the cases have been reviewed by military boards. One of the boards reviewing the cases was moving so slow, it was going to take seven years for all the cases to be reviewed, Stichman said.

## **AFTER 8 DEPLOYMENTS, ARMY RANGER TAKES OWN LIFE**

Wash. – A soldier's widow says his fellow Army Rangers wouldn't do anything to help him before he took his own life – after eight deployments to Iraq and Afghanistan. The Army found Staff Sgt. Jared Hagemann's body at a training area of Joint Base Lewis McChord a few weeks ago. A spokesman for the base tells KOMO News that the nature of the death is still undetermined. But Staff Sgt. Hagemann's widow says her husband took his own life – and it didn't need to happen.

"It was just horrible. And he would just cry," says Ashley Hagemann.

Ashley says her husband Jared tried to come to grips with what he'd seen and done on his eight deployments in Iraq and Afghanistan. "And there's no way that any God would forgive him – that he was going to hell," says Ashley. "He couldn't live with that anymore."

Ashley says her Army Ranger husband wanted out of the military. "He just wanted to know what it felt like to be normal again," she says.

Staff Sgt. Hagemann had orders to return to Afghanistan this month for a ninth tour of duty.

## **G.I. BILL CUTS: VETERANS ENROLLED IN COLLEGE FACE UNCERTAIN FUTURES**

MADISON, Wis. -- Nearly two years ago, Stephen Lee uprooted his wife and two children from their home in Clarksville, Tenn., to study political science here at the University of Wisconsin. As a 31-year-old Army veteran, Lee took advantage of one of the most successful tuition assistance programs in the nation's history -- the G.I. Bill. In exchange for his nine years of military service, the federal government agreed to pay for Lee's college education.

But on a brittle February night, the rules suddenly changed. At a Vets for Vets meeting on campus, Lee listened in disbelief as a university official told his classmates that the government had reneged on its original promise. In December, Congress voted to cut their G.I. Bill benefits.

Lee closed his eyes and bowed his head. The official said that, beginning in August, out-of-state residents at the university would face caps on their tuition assistance pegged at whatever in-state students had to pay. Lee, who became a Tennessee resident while stationed at Fort Campbell, now owed an extra \$8,000 per semester. Beginning next fall, he and 56 other out-of-state residents attending the university on the G.I. Bill needed to come up with \$16,000 in order to finish out the year -- an increase in cost none of them could afford without going into debt.

## **WAR VETS STRUGGLE TO FIT BACK INTO SOCIETY**

Homeless and feeling helpless, Joshua Crowell called the Department of Veterans Affairs to say he felt like killing himself.

Three months earlier, a friend had driven the 23-year-old Army veteran to the gates of Fort Bragg and dropped him off. Crowell had been booted out of the Army on an other-than-honorable discharge for misconduct.

"That meant I lost my college, I lost my unemployment, I lost everything I'd worked for," Crowell said.

On July 29, when police responded to his threat of suicide at a park in downtown Fayetteville, Crowell told them he wanted to jump off a bridge or into traffic.

Police took Crowell to the psychiatric ward at Cape Fear Valley Medical Center, where he was diagnosed with depression.

Five days later, Crowell was back on the streets, still homeless, broke and alone.

## **INTEGRATED DISABILITY EVALUATION SYSTEM STILL A CLUNKER**

The joint Defense/VA Integrated Disability Evaluation System, under development since 2007, is supposed to expedite the process to determine whether troops remain on active duty or, if they are discharged, what their benefits will be. But this supposedly new and improved system cannot speedily handle the most obvious of cases, as Crystal Nicely, whose Marine husband Todd lost both arms and legs in Afghanistan in 2010 told a hearing of the Senate Veterans Affairs Committee this Tuesday.

Nicely said that while IDES "is supposed to be a faster, more efficient way to complete the evaluations and transition service members, that has not been our experience." For example, Nicely said, "a very simple narrative summary of how my husband was injured sat on someone's desk for almost 70 days waiting for a very simple approval." She said the system started to work only after the intervention of Sen. Patty Murray, D-Wash. Since 43,000 troops have been wounded over the past decade in Afghanistan and Iraq, Murray will be mighty busy if she has to intervene in the thousands of cases still stuck in IDES.

In 2000, Ethel Brown, the widow of Vietnam Veteran Thomas T. Brown, made a claim for benefits based on her belief that her husband had contracted stomach cancer and subsequently died because of Agent Orange exposure during his service in Vietnam. Mr. Brown had done two tours of duty in Vietnam and Mrs. Brown contended that she should be granted DIC (Dependency and Indemnity Compensation) benefits. In 2008 Mrs. Brown hired the law firm of Jackson & MacNichol to represent her when her claim had reached the Court of Appeals for Veterans Claims in Washington, DC. (Docket No. 07-2220). The firm persuasively briefed the case and on July 1, 2009 Judge Davis wrote a single judge opinion reversing the unfavorable decision by the Board of Veterans Appeals and remanding the case for a new hearing by the Board.

... Mrs. Brown will now get her monthly benefits retroactive to the filing of her claim back in 2000.

### NATIONAL GUARD AND RESERVE ACTIVATED AS OF SEPTEMBER 27, 2011

This week the Army and Marine Corps announced a decrease in activated reservists, while the Navy, Air Force and Coast Guard announced an increase. The net collective result is 1,137 fewer reservists activated than last week. At any given time, services may activate some units and individuals while deactivating others, making it possible for these figures to either increase or decrease. The total number currently on active duty from the Army National Guard and Army Reserve is 70,251; Navy Reserve, 4,719; Air National Guard and Air Force Reserve, 11,145; Marine Corps Reserve, 5,681, and the Coast Guard Reserve, 674. This brings the total National Guard and Reserve personnel who have been activated to 92,470, including both units and individual augmentees. #### GULF WAR CLAIMS DEADLINE

Week of September 19, 2011

For Gulf War Veterans with certain ailments like: Chronic fatigue syndrome; Fibromyalgia; Functional gastrointestinal disorders; and other undiagnosed illnesses the current deadline for when the condition must have "appeared" is on or before December 31, 2011. If you have any conditions that are "undiagnosed" and you did a tour in the Middle East, this could apply to you. The VA is working to extend the deadline to December 31, 2018. If this occurs, it will be great news for veterans and military members who develop symptoms after the 2011 cut-off. However, since there is no guarantee that the deadline will be extended, veterans suffering from undiagnosed conditions are encouraged to talk with their Veteran Service Officer about filing a disability claim for these conditions.
