### MEMORIALS ARE OFTEN MASKS FOR REAL CARE

I have rung this bell before, but memorials to the dead just piss me off! Not because the dead don't deserve it – they generally do. Not because we veterans don't want to remember our fallen brothers and sisters – nothing could be further from the truth.

What pisses me off is that memorials are a convenient way for those who did not place themselves at risk to claim that they have participated. By building a monument or giving some “patriotic” speech “In Memoriam”, they can claim that they have done their duty. They aren't really lying, because they seem to believe it themselves.

Memorials are for us only one part of our lives; an important part, but just a part.

The beauty of the Vietnam Memorial, now 25 years old, is not just that it is a grand architectural tribute to sacrifice, but that it contains the names. It is the names that make it important to us. We remember them, not in the abstract – not as “the fallen” – but as our friends and companions in a bloody business.

But we must not use the memorials, and we certainly must not use the “patriotic” speeches, in lieu of doing something real about those who still are with us.

In a recent movie, *“The History Boys”*, a young teacher talks to his students about just this subject, when he says,

“Truth was that in 1914 Germany doesn't want war. Yeah, there's an arms race but Britain is leading.

So, Why does no one admit this? That's why (pointing at a World War I memorial statue).

The dead – the body count. [It's alright not] to admit that the war is even partly our fault, because so many of our people died.

And all the mourning veils the truth. It's not ‘Lest we forget.’, it's ‘Lest we remember.’

See, that's what it's all about. The memorials – the cenotaphs – the two minute's silence.

For there is no better way of forgetting something than by commemorating it.”

As a people – as a nation – when it comes to veterans we more or less address those things that we can see, or rather those things that

we cannot hide. A young soldier has lost a leg, we provide a prosthetic. Another young soldier has lost his or her sight, we provide training and a guide dog (although lately we have asked volunteers to make that pricy contribution for us). But when young soldiers lose their ability to relate to normal society, or if they lose their grounding in their own humanity, this is off our radar screen. We can ignore it because it is not physically apparent. When confronted with it, we can even hint that it is perhaps un-American to be wounded in spirit, thus the fault must lie with the individual veteran, never with society.

In a marvelous book *“On Killing”*, a book that should be read by all, especially by those who think that psychological trauma must be the soldier's fault, Lt. Col. Dave Grossman, an expert on PTSD, says,

“In many ways it is simply too painful for society to address what it does when it sends its young men off to kill other young men in distant lands. And what is too painful to remember, we simply choose to forget. ... [quoting Peter Marin] “we seem unable to deal with [a veteran's] moral pain or guilt. Instead it is treated as a neurosis or a pathology, ‘something to escape rather than something to learn from, a disease rather than – as it may well be for the vets – an appropriate if painful response to the past.”

In another story from World War I, one which I have quoted before, the mother of a dead British soldier – her favorite son – spends the day on which she learns of his death writing letters for the wounded in hospital. When asked why she stayed, she says,

“The dead must wait on the living.”

This Veterans Day let's use our time for good. Spend that time that you need to memorialize your brothers and sisters, then get something done for those who are still with us and are wounded in both body and spirit. Let's really honor those who are gone by tending to their comrades who stay with us and are wounded in many ways..

Today's veterans are those who raced toward the sound of battle while many cowered in fear. Remember all of them, alive and dead!

Tend to the living, and keep the dead in your heart. [Ed.]

## RECALL - FEDERAL AND STATE LEGISLATION AND LEGISLATORS

### **\$471 BILLION, “WAR ON TERROR” NOT INCLUDED**

In a closed session on Tuesday, a Congressional appropriations conference committee approved \$471 billion in defense spending for 2008, a 9.5 percent increase over last year. Although a separate bill allocating war funds will probably follow soon, Democrats succeeded in keeping money specifically for operations in Iraq and Afghanistan out of this general defense appropriations bill. Sen. Ted Stevens (R-Alaska) raised an amendment in conference to add a \$70 billion "bridge fund" for the "war on terror" to the bill, but the proposal was defeated with a vote along party lines, according to Jesse Jacobs, press secretary for Senate Appropriations Committee Chairman Robert Byrd (D-West Virginia).

### **EVEN CUT 50 PERCENT, EARMARKS CLOG A MILITARY BILL**

WASHINGTON, Nov. 3 — Even though members of Congress cut back their pork barrel spending this year, House lawmakers still tacked on to the military appropriations bill \$1.8 billion to pay 580 private companies for projects the Pentagon did not request. Twenty-one members were responsible for about \$1 billion in earmarks, or financing for pet projects, according to data lawmakers were required to disclose for the first time this year. Each asked for more than \$20 million for businesses mostly in their districts, ranging from major military contractors to little known start-ups. The list is topped by the veteran earmark champions Representative John P. Murtha, a Pennsylvania Democrat who is the chairman of the powerful defense appropriations subcommittee, and Representative C. W. ### **ONE DOWN: OBSCENELY DECADENT WAR PROFITEER HAULED OFF IN HANDCUFFS**

It looks like the party may be over for one corporate crook. America's most ostentatious war profiteer is no longer a free man. In a long-anticipated move, FBI agents arrested bulletproof vest maker David H. Brooks in his Manhattan apartment at dawn on Thursday. In the tradition of Al Capone, Brooks was nabbed on allegations of financial shenanigans, despite strong suspicions that the defense contractor has much more serious crimes on his hands.

... What makes Brooks' greed particularly obscene is that the bullet-proof vests that boosted his fortunes in the first place turned out to be not so bulletproof after all. ### **DEFENSE CONTRACT AWARD PROTESTED**

WASHINGTON -- A Defense Department medical services contract worth up to \$790 million was awarded last month to a Wisconsin-based company three months after it hired a former Bush administration appointee who had supervised military health programs at the Pentagon for the last six years.

William Winkenwerder Jr., assistant secretary of Defense for health affairs from 2001 until April, joined Logistics Health Inc. as a director and consultant in June. The firm beat out two other bidders with proposals that ranged from \$80 million to \$100 million less, records show. Under the new contract, Logistics Health will provide immunizations and physical and dental exams for reservists and National Guard members. Logistics Health of LaCrosse, Wis., is headed by another ex-official of the Bush administration -- former Secretary of Health and Human Services Tommy Thompson.

### **DOD LOOKS TO EASE RECRUITMENT STANDARDS**

WASHINGTON - Faced with higher recruiting goals, the Pentagon is quietly looking for ways to make it easier for people with minor criminal records to join the military, The Associated Press has learned. The review, in its early stages, comes as the number of Army recruits needing waivers for bad behavior - such as trying drugs, stealing, carrying weapons on school grounds and fighting - rose from 15 percent in 2006 to 18 percent this year. And it reflects the services' growing use of criminal, health and other waivers to build their ranks.

Overall, about three in every 10 recruits must get a waiver, according to Pentagon statistics obtained by AP, and about two-thirds of those approved in recent years have been for criminal behavior. Some recruits must get more than one waiver to cover things ranging from any criminal record, to health problems such as asthma or flat feet, to low aptitude scores - and even for some tattoos. <More at: [www.military.com/NewsContent/0,13319,155644,00.html](http://www.military.com/NewsContent/0,13319,155644,00.html)>

### A REASON TO QUESTION THE SIX-MONTH LIMITATION ON IDENTIFYING PTSD

### IRAQ, AFGHAN VETS AT RISK FOR SUICIDES

WASHINGTON (AP) - Mary Gallagher did not get a knock at the door from a military chaplain with news of her Marine husband's death in a faraway place. Instead, the Iraq war veteran committed suicide eight months after returning home. She is left wondering why. It's a question shared by hundreds of families of Iraq and Afghanistan veterans who have taken their own lives in a homecoming suicide pattern of a magnitude that is just starting to emerge.

Preliminary Veterans Affairs Department research obtained by The Associated Press reveals for the first time that there were at least 283 suicides among veterans who left the military between the start of the war in Afghanistan on Oct. 7, 2001 and the end of 2005.

... Today's home front suicide tally is running at least double the number of troop suicides in the war zones as thousands of men and women return with disabling injuries and mental health disorders that put them at higher risk. A total of 147 troops have killed themselves in Iraq and Afghanistan since the start of the wars, according to the Defense Manpower Data Center, which tracks casualties for the Pentagon.

Add the number of returning veterans and the finding is that at least 430 of the 1.5 million troops who have fought in the two wars have killed themselves over the past six years. And that doesn't include people like Gallagher's husband who committed suicide after their combat tours and while still in the military - a number the Pentagon says it doesn't track.

### **VA SAYS 6 PERCENT OF COMBAT VETS HAVE TBIS**

About 6 percent of Afghanistan and Iraq war veterans seeking treatment at Department of Veterans Affairs hospitals have been diagnosed with traumatic brain injuries, according to preliminary data released Friday. A VA mandatory screening program that took effect in April has looked at 61,285 veterans of the wars. Of those, 19.2 percent were identified on the screening questionnaire as potentially suffering from traumatic brain injuries and were referred for more tests.

#### **MORE ARIZONA VETS SEEKING TREATMENT FOR PTSD AP**

TUCSON, Ariz. (AP) - Arizona Army National Guard Sgt. Lisa Hernandez rocks back and forth and tears begin to fall as she talks about her effort to return to civilian life after returning to Tucson from Iraq two months ago. Hernandez, 38, is divorced with sole custody of the four children she left behind when she was deployed to Operation Iraqi Freedom. She is one of 462 war veterans diagnosed with post-traumatic stress disorder from among the 1,483 veterans who have sought medical care at the Southern Arizona Veterans Affairs medical facility in Tucson between Oct. 1, 2006, and Sept. 30, 2007.

Mansfield. "We will make it easier for these heroes to go back to their homes, with the key questions about their eligibility for VA compensation already decided."

#### **NOT SEMI-SOLDIERS**

It's no longer a question of whether women should be in combat. It's a matter of the regulations catching up with the reality.

When Leigh Ann Hester came home from Iraq she put grenade pins on her key ring. They were souvenirs of the Sunday morning in March 2005 when she and her Kentucky National Guard unit were tailing a supply convoy outside Baghdad. As many as 50 insurgents with submachine guns and rockets began to fire from an orchard and trenches along the road. The Americans pulled their Humvees over, and Sergeant Hester and S/Sgt. Timothy Nein crawled into one of the trenches. She shot a rifle while he lobbed grenades, then she threw while he fired. In 25 minutes the squad had killed 27 insurgents. Leigh Ann Hester, then age 23, was awarded the Silver Star for exceptional valor, the first woman ever to receive the honor for offensive action against the enemy. Which is remarkable, considering the regulations designed to keep people like Sergeant Hester out of combat.

### **HOMELESS IN AMERICA: 1 IN 4 ARE VETS**

WASHINGTON - Veterans make up one in four homeless people in the United States, though they are only 11 percent of the general adult population, according to a report released Nov. 8. And homelessness is not just a problem among middle-age and elderly veterans. Younger veterans from Iraq and Afghanistan are trickling into shelters and soup kitchens seeking services, treatment or help with finding a job.

The Veterans Affairs Department has identified 1,500 homeless veterans from the current wars and says 400 of them have participated in its programs specifically targeting homelessness.

The Alliance to End Homelessness, a public education nonprofit, based the findings of its report on numbers from Veterans Affairs and the Census Bureau. 2005 data estimated that 194,254 homeless people out of 744,313 on any given night were veterans. In comparison, the VA says that 20 years ago, the estimated number of veterans who were homeless on any given night was 250,000.

Some advocates say such an early presence of veterans from Iraq and Afghanistan at shelters does not bode well for the future.

### **MORE RESERVISTS REPORT JOB PROBLEMS**

WASHINGTON (AP) - Strained by extended tours in Iraq, growing numbers of military reservists say the government is providing little help to soldiers who are denied their old jobs when they return home, Defense Department data shows. The Pentagon survey of reservists in 2005-2006, obtained by The Associated Press, details increasing discontent among returning troops in protecting their legal rights after taking leave from work to fight for their country.

It found that 44 percent of the reservists polled said they were dissatisfied with how the Labor Department handled their complaint of employment discrimination based on their military status, up from 27 percent from 2004. Nearly one-third, or 29 percent, said they had difficulty getting the information they needed from government agencies charged with protecting their rights, while 77 percent reported they didn't even bother trying to get assistance in part because they didn't think it would make a difference.

### **A POST-IRAQ G.I. BILL**

MEMBERS of Congress and other political leaders often say that the men and women who have served in our military since 9/11 are the "new greatest generation." Well, here's a thought from two infantry combat veterans of the Vietnam era's "wounded generation": if you truly believe that our Iraq and Afghanistan veterans are like those who fought in World War II, let us provide them with the same G.I. Bill that was given to the veterans of that war.



In terms of providing true opportunity, the World War II G.I. Bill was one of the most important pieces of legislation in our history. It paid college tuition and fees, bought textbooks and provided a monthly stipend for eight million of the 16 million who served. Many of our colleagues in the Senate who before the war could never have dreamed of college found themselves at some of the nation's finest educational institutions. Frank Lautenberg of New Jersey went to Columbia on the G.I. bill; John Warner of Virginia to Washington and Lee and the University of Virginia Law School; Daniel Inouye of Hawaii to the University of Hawaii and the George Washington University Law School; and Ted Stevens of Alaska to UCLA, and Harvard Law School.

Veterans today have only the Montgomery G.I. Bill, which requires a service member to pay \$100 a month for the first year of his or her enlistment in order to receive a flat payment for college that averages \$800 a month. This was a reasonable enlistment incentive for peacetime service, but it is an insufficient reward for wartime service today. It is hardly enough to allow a veteran to attend many community colleges. It would cover only about 13 percent of the cost of attending Columbia, 42 percent at the University of Hawaii, 14 percent at Washington and Lee, 26 percent at U.C.L.A. and 11 percent at Harvard Law School.

### **NATIONAL GUARD AND RESERVE MOBILIZED AS OF NOVEMBER 7, 2007**

This week, the Air Force announced an increase, while the Army and Marine Corps announced a decrease. The net collective result is 636 less reservists mobilized than last week. At any given time, services may mobilize some units and individuals while demobilizing others, making it possible for these figures to either increase or decrease. The total number currently on active duty in support of the partial mobilization of the Army National Guard and Army Reserve is 72,642; Navy Reserve, 5,895; Air National Guard and Air Force Reserve, 7,113; Marine Corps Reserve, 7,265; and the Coast Guard Reserve, 347. This brings the total National Guard and Reserve personnel who have been mobilized to 93,262, including both units and individual augmentees. ### **MILITARY'S PORN BAN QUESTIONED**

WASHINGTON — Ten years after Congress banned sales of sexually explicit material on military bases, the Pentagon is under fire for continuing to sell adult fare, such as Penthouse and Playmates In Bed, that it doesn't consider explicit enough to pull from its stores.

Dozens of religious and anti-pornography groups have complained to Congress and Defense Secretary Robert Gates that a Pentagon board set up to review magazines and films is allowing sales of material that Congress intended to ban.

"They're saying 'we're not selling stuff that's sexually explicit' ... and we say it's pornography," says Donald Wildmon, head of the American Family Association, a Christian anti-pornography group. A letter-writing campaign launched Friday by opponents of the policy aims to convince Congress to "get the Pentagon to obey the law," he adds.

ON DEADLINE: Dept. of Defense responds

In an Aug. 15 letter to the groups, Leslye Arsht, a deputy undersecretary of Defense, said the Pentagon's Resale Activities Board of Review uses appropriate guidelines to review material for sale.

This year, the board reviewed Penthouse and several Playboy publications and determined that "based solely on the totality of each magazine's content, they were not sexually explicit," Arsht wrote. Replied Dornbock: "It's a common misperception that there should be an overwhelming amount of every \$1. There are expenses along the way."

A "common misperception" that if you donate money to paralyzed veterans, that most of the money should get to, well, paralyzed veterans?

No. The only misperceptions here are that many donors still think that everyone in the charity world is out to help others, and that I thought I'd seen the depths that human beings could sink to in their quests to line their own pockets at the expense of good donors and needy recipients.

Please don't give to these telemarketing groups, especially those that purport to represent our veterans. 99 times out of 100, they're bogus telemarketers, representing only themselves, and they know that the nation is filled with sympathetic but unsuspecting donors who would never dream that the person on the other end of the telephone line isn't really as honorable or patriotic as the people they claim to be fundraising for (or from).
