## RECALL - FEDERAL AND STATE LEGISLATION

### PROGRESS OF THE “CALIFORNIA SHARED SACRIFICE ACT”

We are working to get more legislators to sign on to sponsor the act; we believe that we now have five. If we are successful this will be a model for state action for veterans and active duty personnel and their families for the whole nation. The text of the legislation is on the website.

### WHAT CAN HAPPEN TO WELL-MEANING LEGISLATION WHEN THE LOBBYISTS GET THEIR WAY

Recently Senator Elizabeth Dole (R-NC) proposed an amendment to Department of Defense Authorization Bill, S. 1042; the amendment was titled the **Predatory Lending Amendment**, and would restrict loans to military and their families to an annual interest rate of 36% APR (usury in my opinion, but better than what has been happening). The original amendment garnered much support including many consumers’ groups and most of the national military organizations (see the supporting letter at <http://www.uspirg.org/consumer/archives/doletmc.pdf>). Now the amendment has been fiddled with and revised, and at least some of the major national consumers groups have withdrawn their support for the amendment and are urging its rejection <http://www.uspirg.org/consumer/archives/dolewithdraw.pdf>. Their message is that the amendment has been tinkered with so much that it now would harm service members more than it would help.

Congratulations to Senator Dole for her initiative, and shame on those who have knuckled under to pressure from lobbyists for the lending industry.

### 2,000 DEAD? WHO CARES?

#### **Why is the country so oblivious to the Iraq war's casualties?**

Sometime soon the war in Iraq will claim the life of the 2,000th G.I., a gut-wrenching milestone in the bloodiest conflict for the United States since Vietnam. Reports of deaths, particularly recently, have been coming in at a frightening clip. On Oct. 6, six Marines were killed by roadside bombs in attacks near Qaim and Karmah, bringing the total of American soldiers who have been killed in Iraq to 1,951. **[Now 1,997 Ed.]**

Vietnam analogies can be dubious or prescient, depending on whom you ask. The 2,000th G.I. fell in Vietnam sometime during 1965, six years after the first two Americans were killed in a guerrilla attack. The final death count from Vietnam was 58,209.

The death rate in Iraq may not compare to those of World War I and World War II, in which, respectively, 116,516 and 405,399 U.S. soldiers were killed. Nevertheless, nearly three years into the war in Iraq, the mounting death toll doesn't seem to register with Americans. If Korea was the forgotten war, Iraq is invisible.

Military analysts say the outcry over deaths in Iraq is muted because the burden of war falls on a tiny percentage of Americans and their families. Most Americans simply don't have any personal connection to the battlefield.

### **ADMINISTRATION'S TONE SIGNALS A LONGER, BROADER IRAQ CONFLICT**

WASHINGTON, Oct. 16 - For most of the 30 months since American-led forces ousted Saddam Hussein, the Bush administration has argued that as democracy took hold in Iraq, the insurgency would lose steam because Al Qaeda and the opponents of the country's interim government had nothing to offer Iraqis or the people of the Middle East.

Over time, President Bush told troops at Fort Bragg, N.C., this spring, "the terrorists will lose their sponsors, lose their recruits, and lose their hopes for turning that region into a base for attacks on America and our allies around the world."

But inside the administration, that belief provides less solace than it once did. Senior officials say the intelligence reports flowing over their desks in recent months argue that even if democratic institutions take hold, the insurgency may strengthen. And that possibility has created a quandary for an administration that desperately wants to equate democracy-building with winning the war, but so far has not been able to match the two.

### **U.S., BRITAIN URGE ACTION AGAINST SYRIA**

The United States and Britain called Sunday for an international stand against Syria in the wake of a U.N. report that implicated Syrian officials in the assassination of a former Lebanese leader. Syria countered by discounting the report as an American plot and began a diplomatic drive to explain its position. ... The U.S.-British call for action, in a joint BBC interview by Secretary of State Condoleezza Rice and British Foreign Secretary Jack Straw, underlined the growing pressure on Syria as it faces possible action by the U.N. Security Council later this week.

"The report indicated that people of a high level of this Syrian regime were implicated," Straw told the BBC. "We also have evidence .... of false testimony being given by senior people in the regime. This is very serious."

Rice called for "a firm response" from the international community.

Officials in Washington have said privately that the United States is considering pushing for possible U.N. sanctions against Syria, or to have any criminal cases heard by an international tribunal.

#### **THE IRAQ WAR COMES HOME**

The Iraq war is coming home, with more than one of every four returning vets complaining of mental or physical wounds caused by the conflict. The first time the U.S. went to war with Iraq, in 1991, ground combat lasted precisely 100 hours, but its impact on the U.S. troops who waged it, including physical and mental scars, was ignored and belittled by the Pentagon hierarchy for years. #### **ANOTHER IRAQ WAR LEGACY: BADLY WOUNDED U.S. TROOPS**

WASHINGTON (Reuters) - U.S. Army Sgt. Joey Bozik remembers coming out of a coma at Walter Reed Army Medical Center not fully understanding why he was there.

"I knew something had happened to me, I just didn't know what," Bozik said.

He first inquired about his family, then about himself.

"I had an above-the-knee amputation of my right leg and a below-the-knee amputation on my left leg. I had a below-the-elbow amputation on my right arm. And on my left hand, my thumb and pinkie were fractured and the metacarpals in my hand were fractured and I fractured my wrist," Bozik said.

The human toll for the U.S. military in the Iraq war is not limited to the nearly 2,000 troops deaths since the March 2003 invasion. More than 15,220 also have been wounded in combat, including more than 7,100 injured too badly to return to duty, the Pentagon said. Thousands more have been hurt in incidents unrelated to combat.

#### **GUARD, RESERVES BEAR HIGHER SHARE OF CASUALTY RATE**

The National Guard and Reserves are suffering a strikingly higher share of U.S. casualties in Iraq, their portion of total American military deaths nearly doubling since last year.

Reservists have accounted for one-quarter of all U.S. deaths since the Iraq war began, but the proportion has grown over time. It was 10 percent for the five weeks it took to topple Baghdad in the spring of 2003, and 20 percent for 2004 as a whole.

The trend accelerated this year. For the first nine months of 2005 reservists accounted for 36 percent of U.S. deaths, and for August and September it was 56 percent, according to Pentagon figures.

The Army National Guard, Army Reserve and Marine Corps Reserve accounted for more than half of all U.S. deaths in August and in September — the first time that has happened in consecutive months. ## **FROM WAR HERO TO WAR HAUNTED**

### **Long Island Iraq War veteran depicted in famous image details struggle with menacing post-traumatic stress disorder that escalated to a standoff with po**



Army Spc. Joseph Dwyer angled a mirror out the back window of his apartment in El Paso, Texas, trying to make out the Iraqis in the evening gloom. He couldn't see them, but he felt that they were out there somewhere, ready to attack.

Holding his 9-mm handgun tight, the 29-year-old medic from Mount Sinai phoned in an air strike using military code. He directed the fighter jets to his own street address.

Then he heard a noise from the roof -- maybe an Iraqi trying to get in? -- and that's when Dwyer began firing.

Nobody was hurt in the three-hour standoff Oct. 6 in which Dwyer, deep in a post-traumatic stress-induced delusion, barricaded himself into his apartment, fighting off an imaginary Iraqi attack.

Back then, an image of hope

### **INJURED SOLDIERS BRING HOME RARE INFECTION**

A recent outbreak of *Acinetobacter baumannii* infections among patients at military medical facilities across the country is presenting a treatment challenge for clinicians, adding to the cost of medical care, and raising concerns that injured soldiers may be importing rare bugs from overseas into U.S. hospitals.

Since March 2003, more than 250 injured soldiers have been diagnosed with *A. baumannii* infection. ### **AILING VETERANS BLAME THEIR MULTIPLE SCLEROSIS ON GULF WAR**

#### **Ailing veterans blame their MS on Gulf War - Their mission now is to spread the word about other illnesses**

On a morning at Westlake Center, they were a couple of wives and moms spending quality time downtown, meeting at a coffee shop to catch up on their lives.

Yet Julie Mock, 38, of Woodinville and Elizabeth Burris, 50, of Tacoma are also sisters-in-arms, exposed accidentally to deadly nerve gases. As veterans of the 1991 Persian Gulf War, they are among perhaps 450 men and women across the country who blame their multiple sclerosis on that war's poisonous stew.

Though overshadowed by today's costlier war in Iraq, Persian Gulf War veterans are still taking casualties.

Of the 700,000 U.S. troops who served there in 1991, a disproportionate number experienced serious neurological disorders. More than 65 percent have sought health care for service-related ailments. Nearly 200,000 are receiving disability compensation -- twice the rate as vets from World War II, Korea and Vietnam.

The federal government this summer began notifying about 300,000 veterans of the latest neurological problem linked to service in Iraq in 1991 -- brain cancer. It was the third time the government had warned veterans about neurological problems.

Brain-cancer death joined amyotrophic lateral sclerosis, commonly known as Lou Gehrig's disease, and fibromyalgia among the attacks upon nervous systems stemming from the Gulf War.

In addition, Mock says, "The rate of multiple sclerosis is rising among Gulf War veterans. ... Our population of veterans is becoming increasingly ill and, after years of pushing onward, are finding ourselves too ill to work."

## **SENATE PASSES MURRAY'S AMENDMENT TODAY; BLOCKS VA FROM WASTING RESOURCES INVESTIGATING 72,000 VETERANS AND PENALIZING THOSE WITH PAPERWORK ERRORS**

September 22, 2005 - Washington, D.C.

Today, U.S. Senator Patty Murray (D-Wash) stood up for America's veterans by ensuring that those who need help with Post Traumatic Stress Disorder (PTSD) are not scrutinized, stigmatized, or penalized by a planned VA investigation.

"Veterans with PTSD deserve the VA's compassion and support, not costly investigations, penalties and stigma," Murray said. "Veterans should not be punished for mistakes the VA has made, and that's what my amendment ensures."

Earlier this year, the VA announced plans to investigate the PTSD disability claims of 72,000 veterans. An earlier study of a small number of cases by the VA's Inspector General found errors in about one-third of the claims examined. Many of the problems uncovered were paperwork errors.

## **UDALL: REVIEW OF BENEFITS DOES HARM TO VETERANS**

WASHINGTON - A New Mexico veteran's suicide this month might have been linked to a government review of disability benefits for veterans suffering from post-traumatic stress disorder, Rep. Tom Udall (D-Santa Fe) and New Mexico Veterans Services Secretary John Garcia told a congressional hearing.

"He believed, as so many veterans do, that he was being forced to prove himself again," Udall, a Santa Fe Democrat, said during Thursday's hearing.

Another veteran had to be talked out of committing suicide because of the benefits review, Garcia told the House Veterans' Affairs subcommittee on disability assistance.

Udall urged Bush administration officials to halt the 2,100 cases already under review.

## **VETERANS' BENEFITS ARE NOT SAFE**

Rep. Steve Buyer was right! Everything is "on the table" when it comes to veterans' benefits. Rep. Buyer (R-IN) <http://stevebuyer.house.gov/>, Chairman of the House Committee on Veterans' Affairs <http://www.veterans.house.gov/>, is smiling. He's won the first round in the battle to re-write the veterans' benefits handbook.

In August, the Department of Veterans Affairs (VA) announced it would be reviewing 72,000 Post-Traumatic Stress Disorder (PTSD) awards granted between 1999 and 2004. This amounts to about one-third of all PTSD claims. The majority of the awards went to Vietnam veterans who have battled the VA, many for ten years or longer, to receive compensation for PTSD. The awards to be reviewed will be ones where full disability (100%) for PTSD was granted. ### **IRAQ WAR VETERAN RECOVERING IN POMONA**

He made it six months into his second tour of duty in Iraq before a sniper's bullet found him as he stood guard on top of a police station.

The bullet never actually entered his body, rather it zipped around the inside of his helmet and back out, shaking his head violently and injuring his brain.

In the next few weeks, Army Staff Sgt. Jarod Behee of Glendora is looking at more surgery at a private hospital in Pomona where he was recently moved.

Behee, 26, will undergo surgery to insert a permanent shunt to drain the fluid on his brain. After that, doctors will perform a cranioplasty to relieve pressure on his brain.

His right eye won't stay open, so he'll face a third surgery.

And when he moves from the hospital setting into a transitional living center at Casa Colina Centers for Rehabilitation, that's when his wife, Marissa, says she's not sure his insurance will pay for his treatment. His hand had been blown off in Iraq, his body pierced by shrapnel. He could not walk. Robert Loria was flown home for a long recovery at Walter Reed Army Medical Center, where he tried to bear up against intense physical pain and re-imagine his life's possibilities.

The last thing on his mind, he said, was whether the Army had correctly adjusted his pay rate -- downgrading it because he was out of the war zone -- or whether his combat gear had been accounted for properly: his Kevlar helmet, his suspenders, his rucksack.

But nine months after Loria was wounded, the Army garnished his wages and then, as he prepared to leave the service, hit him with a \$6,200 debt. That was just before last Christmas, and several lawmakers scrambled to help. This spring, a collection agency started calling. He owed another \$646 for military housing.

### **WOUNDED TROOPS: PAY MISTAKES ADD TO HARDSHIP**

Having nearly lost his life in Iraq, the 1st Infantry Division soldier became lost to the Army payroll system because of a paperwork snafu as he lay comatose in a veterans hospital near Chicago. As a result, an Army bureaucrat classified him as absent without

leave and cut off his pay, as is sometimes done when the system loses track of a soldier. The theory is that a GI wrongly listed as AWOL will start shouting and then the issue can be resolved.
