## FIRST CALL – NOTES FROM THE FRONT

### A NEW LEXICON FOR VETERANS

The fight over veterans’ benefits goes on, even while some are arguing that the current failed system already costs too much. Recent articles, particularly one by AP reporter Alan Breed claims the system is too easily “gamed” and benefits are being given too freely. **“Veterans Benefits” is a great-sounding term; but what do the words really mean—not us, but to others.**

Before we get to that meaning, let’s take a look at what has happened to our language recently. Words, the meaning of which you thought you knew, have slipped away and acquired new meanings.

Let’s start with the ones that just got taken over by someone else.

My grandmother’s favorite descriptor was that one of her friends was *gay*, meaning merry and joyful. Can’t use that one that one anymore. No big deal, and I don’t begrudge today’s gays their label, but my grandmother would be confused.

*Friend* always had a special meaning for me, but now that it is the label for anyone you connect with on “Facebook” or “Twitter”, I guess that it doesn’t mean that you are particularly close.

*Deluxe* always meant better quality but Wendy’s “Deluxe BBQ Bacon Cheeseburger” contains ¼ the calories and ½ the fat of your daily recommended dose – hardly high quality fare.

*Mature* used to define full adulthood, mentally and physically. Now mindless shoot-‘em-up video games

are “Mature” – who is their audience? I’m afraid it is those who will never mature.

It gets worse – much worse!

*Bonus*, which was always a reward for exceptional performance, is now the just due of anyone who shows up for work at a major corporation or financial house, regardless of performance. It may even get larger as the performance deteriorates – I am not sure.

*Regulation* now apparently means looking over the shoulder of a contractor and writing down what he tells you he is doing. It also means writing rules which have no practical meaning in evaluating the task at hand.

*Freedom* has lost its meaning. We are told daily that around the world we are “Fighting for Freedom”, but whose freedom, and freedom from what? Nobody we have been “fighting to free” seems much freer today than they were 8, or 10, or even 50 years ago. And as for my freedom, it hasn’t been significantly threatened by outsiders in over half a century – so where’s the fight?

*Patriotism*, which is supposed to mean loyalty to a nation and a way of life, has been re-defined as blind adherence to the acts of our nation regardless of their worth. Anything less is deemed unpatriotic. In my book, that loyalty has always included a willingness to try to correct your nation’s mistakes by speaking out against its errors—but apparently that’s no longer allowed. So I am not sure exactly what *patriotism* means anymore unless it is now a synonym for *jingoism*, or *xenophobia*, which have clearly retained their meaning.

*Corporation*, instead of meaning a business which has individual liabilities and powers under accepted

law, now means “person”, which used to mean an individual human being with specific rights, duties and responsibilities. This one throws me for a loop.

Ever since Citizens United v. Federal Election Commission I guess corporations can be drafted; can donate blood; can pay taxes at the same rate I do to the same government that I do, on everything that they earn, as I do; can vote ( I don’t know if they get one vote or can cast multiple votes *en bloc* equal to their employment lists); can obey all laws whether or not they agree with them and whether or not they cause them to lose money.

Oh—wait a minute! I am confusing what their obligations are with what yours and mine are, aren’t I? We must do all of those things—they are not required to do any of them. However they can move their money to the Cayman Islands to avoid taxes; can pay themselves bonuses and write it off as an “expense”; can gamble with someone else’s money and get us to pay for their losses; can use stockholders’ money to support political issues without getting their approval.

I can’t do any of those things. I’ll continue to search for a definition of *person* that covers all of these various differences yet makes sense to all of us, but I don’t think that I will be able to find one.

By the way, Citizens United will be glad to sell you a baseball cap commemorating President Bush’s declaration on 2 May 03 that the mission was accomplished. There were 172 coalition casualties by that date in Iraq—now there are 4,723. I guess that the phrase *mission accomplished* also has acquired a meaning that none of us understand. Whatever that meaning now is, *mission accomplished* continues to cost one hell of a lot of lives, ours and others.

There are other changes that, are easy to recognize:

*Defense* now means “Offense”

*Free trade* now means “freebooting”

*Capitalism* means “laissez-fare”—total freedom of action regardless of the consequences

*History* and *tradition* mean “whatever happened in the past without the bad stuff.”

### **We return to deciphering the present-day meaning of *Veterans’ Benefits*.**

None of us should be surprised that neither of the words retain their original meaning—almost nothing else seems to either.

Many veterans are being asked to prove their *veteran* status, even though they present a DD214. Some VBA claims offices are requiring that the

DD214 be an “original”, even though most other agencies allow for certified copies. It is not enough that you have proven yourself by your service—please prove it to a bureaucrat who never served. And the VA wants to make it tougher to prove!

As for *benefits*—even though Congress has passed the laws setting up the various benefits programs, and even though they have funded those benefits, although reluctantly in the past, that isn’t enough. You have to provide proof to some bureaucrat that your condition deserves the benefit. Often your medical records are not sufficient proof. Even if the records are sufficient, they are handled so carelessly that over and over again we hear of records being lost. (Try to recover the complete record once the VA has lost it).

Most tellingly, the benefit, in order to be useful, has to be provided when it is needed. When the VBA prides itself on only taking 176 days to answer a claim, remember that is statistically the truth, but it means that to get at that number at least half of the claimants waited longer – much longer.

If the required benefit, when granted, will provide income, it is highly likely that the veteran who is claiming the disability and its related income is desperately in need of that income NOW, not 176 days or much more from now.

Benefits, like justice, when delayed are benefits denied.

So maybe we have the new meaning for *Veterans’ Benefits* after all. Try this on for size:

#### *Veterans’ Benefits:*

Those funds or services that can be grubbed out of a bureaucracy that is fully funded but which prides itself on giving away as little as possible.

To qualify, each veteran must take on the 220,000 employees of that bureaucracy single-handed, without any opportunity for legal assistance until he or she is denied the benefit.

To further qualify, each veteran must prove what has already been proven by the circumstances of his or her service, and must hope that the proof is not destroyed or lost in the process.

The system’s main criterion is that the veteran almost never get what he or she requires: and if he or she gets something, it never is timely nor commensurate with the level of sacrifice or disability.

That may not be complete but it seems to come pretty close. [Ed.]

#### VETERANS COURT IS SEEKING MENTORS

Many were showing up with post-traumatic stress disorder, homelessness, and alcohol and drug problems that were clearly related to their military service.

### **SHINSEKI'S PROPOSED LEGISLATION COULD NEGATIVELY IMPACT MANY VETERANS**

"Getting rid of the primary basis of appeals and running off the lawyers will surely allow VA to get rid of all those pesky claims on remand."

On May 26, 2010, VA Secretary Eric Shinseki wrote a letter to Congressional leaders urging them to consider his draft legislation titled "Veterans Benefit Programs Improvement Act of 2010."

While there are some excellent ideas in the proposed legislation, we must raise a red flag! Analysis (below) is provided by an attorney who practices veterans' law.

Two biggies affecting legal representation of veterans in the Secretary's proposed legislation.

- 1) They do away with reasons and bases for Board decisions - only "plausible" basis required. Translation, almost no Board decision could/would be overturnable at the Veterans Court.
- 2) They change the EAJA prevailing party definition to be limited to cases where the claim ultimately results in a monetary benefit. Translation, even if we have to pay we won't have to do it for years or decades. Not to mention that if the claimant dies and no award is ever made, VA will save both the benefit payment and the legal fee.

### **VA SLOW TO IMPLEMENT IG RECOMMENDATIONS**

Washington, D.C. - On Wednesday, June 9, 2010, House Committee on Veterans' Affairs Chairman Bob Filner (D-CA) conducted a hearing to evaluate and examine the progress made by the Department of Veterans Affairs (VA) in complying with VA's Office of Inspector General's (OIG) recommendations. The OIG's target date for VA implementation of OIG recommendations on how to improve in a specific area is within one year of publication of the report. Currently, there are a total of 115 open reports with 694 open recommendations. Most of the open recommendations are tracking the target date; however, 16 reports containing 45 recommendations are over one year old.

**ENLISTMENT RULES CHANGE AFTER FAKER CASE**

DALLAS -- The Army is instituting a new procedure for checking the backgrounds of enlistees who claim to have a military record after a report that a reservist apparently faked a background as a Marine to enter the service.

Recruiters can no longer simply accept discharge papers as proof of service, Douglas Smith, public information officer for the Army recruiting command, told The Associated Press on Thursday. They now must also seek to verify the documents through a military database, he said. The directive follows an AP story last Friday detailing how a Texas man apparently tricked the Army into allowing him to enter a reserve unit as a noncommissioned officer earlier this year.

**AMERICA'S 'CASUALTY GAP'**

Since Sept. 11, 2001, more than 5,000 Americans have lost their lives in the wars in Afghanistan and Iraq ... In honoring their service, we should not overlook a very real though hidden aspect of war: the socioeconomic inequality in who makes the ultimate sacrifice in defense of the nation.

Over the last six years, we have studied this inequality by collecting and analyzing data on the hometowns of more than 400,000 members of the armed forces who died in World War II, Korea, Vietnam and Iraq. By integrating these records with census data, we demonstrate unambiguously that, beginning with the Korean War, disadvantaged communities have suffered a disproportionate share of the nation's wartime casualties, while richer communities have been more insulated from the costs of war. **TROUBLED VETS 'ICED,' BOOTED FROM US**

A former Marine and Gulf War veteran may soon be boarding a flight to Jamaica -- the ticket cost picked up by the U.S. government. But Rohan Coombs, who came to the U.S. from Jamaica as a child, is not looking forward to the return trip. He's being deported.

Coombs is not alone. By some estimates, 3,000 to 4,000 veterans are awaiting deportation, and the deportations have been going on since a 1996 law made it easier for the U.S. to boot out foreign nationals, including legal permanent residents – "green-card" holders – who served in the military if they commit crimes. Collectively, they've been dubbed "Banished Veterans" by those who say that vets – even those who have committed crimes – deserve better than to be booted from the country they served.



Rep. Bob Filner, D-Calif., chairman of the House Veterans Affairs Committee, called the 1996 legislation "a terrible law that has very un-American consequences." He said the law is particularly unfair when it comes to veterans who arrived in the U.S. as children, who grow up not knowing any language but English and knowing only the U.S. as home.

"It seems to me they should not have the threat of deportation," Filner said. "I would say give them citizenship based on the fact they served in our armed forces. It seems a commonsense thing to me."

## **ATTORNEYS GENERAL SUPPORT FATHER OF FALLEN MARINE AGAINST WESTBORO BAPTIST CHURCH**

Forty-five states attorneys general have signed a "friend of the court" brief in support of the father of a fallen Marine who is taking his case against a radical church that picketed his son's funeral to the Supreme Court.

The Westboro Baptist Church, made up primarily of founder Fred Phelps and his family, picketed the funeral of Lance Cpl. Matthew A. Snyder in 2006 because they believe U.S. troop deaths are God's revenge for tolerating homosexuals. Church members held signs that read "God hates you," "You're in hell," and "Semper Fi fags."

Snyder's father Al sued the church, but an appeals court ruled against him earlier this year and ordered him to pay the church \$16,000 in court fees. The case is expected to go before the Supreme Court this fall.

If there is a more moving, more meaningful place in the United States than Arlington National Cemetery, it's hard to think of it. Some 330,000 people are buried there, veterans of past wars and in some cases, family members. So it's no wonder that John McHugh, secretary of the Army, forced out the two top officials at Arlington after reports that there were questions about 211 gravesites and some unmarked graves. There also were burial sites with the wrong headstones.

McHugh offered no explanations and no hesitations. The apparent carelessness in the handling of these sites would not happen again, he said: "That all ends today."

It's all he needed to say, although a report carried in The News & Observer said he apparently had plenty more to say to John Metzler, the cemetery superintendent, who is retiring under pressure along with his deputy, Thurman Higgenbotham. ### ARMY 'LOST CONTROL' OF COLONEL, STILL PAID \$400,000

The U.S. Army sent \$400,000 in military paychecks to Lt. Col. Stephen D. McConnell for more than three years despite the fact that neither the Army nor his wife knew where he was much of the time or what he was doing to earn his pay. McConnell killed himself. Three weeks later, a criminal investigation began to determine whether he defrauded the government by receiving military pay and benefits to which he was not entitled..

Jasinski turned himself in to the Army late last year, after having gone absent without leave (AWOL) in order to seek help for his PTSD. Help, he told Truthout, he was not receiving from the Army, even after requesting assistance on multiple occasions. He was court-martialed and jailed for 25 days for having gone AWOL, during which time he was escorted in shackles to therapy sessions for his PTSD. ### **VBA SETS GOALS, LACKS PLAN**

FOR IMMEDIATE RELEASE June 15, 2010

Washington, D.C. – On June 15, 2010, John Hall (D-NY), Chairman of the Subcommittee on Disability Assistance and Memorial Affairs, conducted a hearing to examine the state of the Veterans Benefits Administration (VBA) at the Department of Veterans Affairs (VA).

In 2009, VA received more than 1,000,000 claims for disability benefits, representing a 14 percent increase in workload from 2008. Currently VA is receiving more than 97,000 new disability claims per month. As of June 5, 2010, there are 546,387 claims pending from veterans seeking compensation and pension disability benefits, with 195,891 (36%) pending longer than 125 days. Including appeals, VA's total claims-related inventory exceeds 1 million, which is the figure most stakeholders use when referring to the claims "backlog".

VBA projects a 16% increase in new disability claims in 2010 and 12% increase in 2011. Casey Elder, who says she suffers migraines and memory loss from a roadside bomb in Iraq, has been told by the VA that the bombing did not cause those problems — despite a VA doctor's diagnosis that she suffered a traumatic brain injury.

After Clay Hunt was shot through the wrist by a sniper in Iraq, the VA misplaced his disability paperwork for four months. Then he was required to visit a series of doctors to verify the extent of his wounds.

### **CHIEF JUSTICE 'STARTLED' BY GOVERNMENT ERRORS IN VETERANS CASES**

When he was in private practice at Hogan & Hartson, Chief Justice John Roberts Jr. did not handle veterans' benefits claims. So, he understandably found "startling" information with which lawyers for veterans are only too familiar: In litigating with veterans, the government more often than not takes a position that is substantially unjustified.

In oral arguments Monday in *Astrue v. Rattliff*, an attorney fee case under the Equal Access to Justice Act, James Leach of Rapid City, S.D., told the Court that 42 percent of Social Security cases result in an EAJA attorney fee award.



"If it's 42 percent, that's quite a high number of cases in which the government's position is found substantially -- not substantially justified as well as legally erroneous," Leach said. "In veterans cases, it's even worse."

### **VETERANS COURT WINNING CASES**

Today is Veterans Day at the Criminal Justice Center. So is every Wednesday, when it's time for Veterans Court, the Hon. and U.S. Army Reserve Capt. Patrick F. Dugan presiding.

Established in March by state Supreme Court Justices Ronald D. Castille and Seamus P. McCaffery, both decorated veterans, the court is one of three in the state, and almost 20 nationwide, exclusively handling veterans' misdemeanor cases.

It's already a success, a "problem-solving" court, like drug court and mental health court, designed to expedite assistance and avoid costly legal delays and jail time. Defendants range from age 20 (Iraq) to 80 (Korea), but the cases are remarkably sad and similar - virtually all male, charged with driving under the influence, disorderly conduct, possession, spousal abuse.

## **MILITARY STILL FAILING TO DIAGNOSE, TREAT BRAIN INJURIES**

The military medical system is failing to diagnose brain injuries in troops who served in Iraq and Afghanistan, many of whom receive little or no treatment for lingering health problems, an investigation by NPR and ProPublica has found.

So-called mild traumatic brain injury has been called one of the wars' signature wounds. Shock waves from roadside bombs can ripple through soldiers' brains, causing damage that sometimes leaves no visible scars but may cause lasting mental and physical harm.

Officially, military figures say about 115,000 troops have suffered mild traumatic brain injuries since the wars began. But top Army officials acknowledged in interviews that those statistics likely understate the true toll. Tens of thousands of troops with such wounds have gone uncounted, according to unpublished military research obtained by NPR and ProPublica.

## **BRAIN-INJURED VETERANS FIGHT TO GET HELP**

WASHINGTON - Improvised bombs rattled former Army Spc. Adam Pittman a dozen times in his three tours in Iraq, most severely when his Bradley fighting vehicle ran over one hidden in the dirt in 2005. Now, part of Pittman's brain has gone dormant, and on most days he can't think straight. He leaves the room and forgets what he was searching for. He gets migraines so piercing that his right eye sometimes curls away from his left. Anger comes easily, inspiring rages that sometimes have his wife terrified for herself and their 3-year-old daughter.

Although Pittman, who lives in Lillington, N.C., left the military in July 2008 complaining of headaches and memory loss, it took nearly a year for him to get a brain scan and another five months to start getting temporary disability benefits.

## **MILITARY TRIES ACUPUNCTURE TO TREAT TROOPS FOR PTSD**

Tony Bailes of Austin was in the Army in 2003 when he injured his back in Iraq and tried everything his doctor recommended. Nothing helped. Then, the pain specialist prescribed acupuncture, and two weeks later, "my back pain was gone," he said.

A combat medic, Bailes returned to Iraq for a second tour in 2005 and came home in 2006 with a different kind of pain: emotional anguish, nightmares and insomnia. He was diagnosed with post-traumatic stress disorder, but antidepressants made him feel worse, he said. Again, he turned to acupuncture — and recovered, he said. Now he's studying the more than 2,000-year-old Chinese practice of using hair-thin needles for healing and planning to make it his life's work.

Acupuncture is endorsed by many Western medicine practitioners as a treatment for physical pain, and now the therapy — along with other Eastern practices, including yoga, meditation and tai chi — is slowly making inroads in Western medicine as a treatment for mental pain. ## **SURVIVORS OF MILITARY SEXUAL TRAUMA CONTINUE TO FACE UPHILL BATTLE IN MILITARY, AT VA**

Washington, D.C. – On May 20, 2010, John Hall (D-NY), Chairman of the Subcommittee on Disability Assistance and Memorial Affairs, and Michael Michaud (D-ME), Chairman of the Subcommittee on Health, conducted a hearing to evaluate military sexual trauma (MST) issues. The Department of Veterans Affairs (VA) refers to MST as the experiences of sexual

harassment and/or sexual assault that occurred while a veteran was in the military. The hearing focused on ways in which the Veterans Benefits Administration (VBA), Veterans Health Administration (VHA), and the Department of Defense (DoD) can better address the needs of veterans impacted by MST and identify ways to better prevent, treat and properly compensate them.

... According to a 1995 DoD study of sexual victimization among active duty service members, acts of sexual harassment were reported by 78% of women service members and 38% of military men. Another study found that rates of sexual assault and verbal sexual harassment were higher during wartime than peacetime in their sample study population. One study found that 23% of female users of the VA health care system reported having experienced sexual assault while in the military. - Results discussed by a VA health professional with veteran, both in a personal face-to-face consultation and a follow-up letter.
- No requirement to enroll in VA health care system to receive registry exam.

### **NEW VA BENEFITS CLAIM FORM: JUST 6 PAGES**

After years of complaints from veterans about having to fill out a 26-page-long benefits claims form for the Veterans Affairs Department, the Office of Management and Budget has approved VA's new six-page form.

... VA spokesman Steve Westerfeld confirmed in a voicemail that VA had shortened VA Form 21-526, as well as creating a new "express claim" form, or 21-526EZ, which is six pages long and requires that the veteran provide his own medical and military records, rather than waiting for VA to gather them.

The EZ form comes as a result of a pilot program mandated by the Veterans' Benefit Improvement Act of 2008. That pilot program will now be expanded to include everyone, according to VA's May Compensation & Pension Service Bulletin

### **VETERANS TRAVEL FARTHER FOR SURGERY WITH NEW POLICY**

### **AFFLUENT AFGHANS MAKE THEIR HOMES IN OPULENT 'POPPY PALACES'**

KABUL -- For rent on Street 6 in the neighborhood of Sherpur: a four-story, 11-bedroom dwelling of pink granite and lime marble, complete with massage showers, a rooftop fountain and, in the basement, an Asian-themed nightclub. Price: \$12,000 a month. It's a relative bargain in this district favored by former warlords and bureaucrats -- Kabul's version of Beverly Hills. There's a war on, but carnival-colored mansions are mushrooming alongside cratered streets and sewage streams. Vast outdoor chandeliers, heated indoor pools and acres of mirrored, skyscraper glass windows abound.

The grandiose houses, derided here as narco-itecture, have become the most obvious symbols of Afghanistan's corruption, which ranks among the world's worst and is fueled both by an enormous influx of U.S. dollars and by the opium trade. They have paralleled a building boom sweeping this and other Afghan cities, fed by the donor money that has helped distort an economy of haves and have-nots.

### **COLONEL'S WIFE ACCUSED OF HARASSING SOLDIERS**

The commander of Fort Bragg has barred the wife of an 82nd Airborne Division colonel from nearly all interaction with her husband's brigade and the unit's families after an investigation found her influence "detrimental to the morale and well-being of both." Sworn statements from the investigation, ordered in January by Lt. Gen. Frank Helmick, accuse Col. Brian Drinkwine's wife, Leslie Drinkwine, of using her husband's position as leverage to repeatedly harass and threaten Soldiers and their families. The statements say the harassment and threats began almost as soon as Col. Drinkwine took command of the 4th Brigade Combat Team in 2008.
